### Program Founder

**Amy D. Waterman, PhD**, is a national transplant innovator and a Professor in Residence at the University of California, Los Angeles in the Division of Nephrology. She is Director of the Transplant

Research and Education Center (TREC) and Deputy Director of the Terasaki Research Institute. In 2019, Dr. Waterman received the American Society of Transplantation Clinician of Distinction Award. Through her research and educational initiatives, Dr. Waterman seeks to 1) understand the critical, modifiable patient, provider, and system barriers to donation and 2) design interventions to overcome them. Dr. Waterman's research has been supported by over \$28 million in federal grants, and she has authored approximately 100 research articles and book chapters.



### Master Trainer

**Jessica Farrell, MSW, LCSW, NSW-C** is the Senior Manager of Social Work Services for Renal Research Institute overseeing the care of more than 2,000 patients. With 17 years of experience as a nephrology social worker, she has spent her entire

career devoted to kidney and dialysis patients. Jessica received her MSW from Virginia Commonwealth University in Richmond in 2004 and has been a member of the Council of Nephrology Social Workers, a Board Member of the Nephrology Social Worker Certification Board, and a member of the National Kidney Foundation Spring Clinical Meetings Planning Committee. Jessica strongly believes in the importance of collaboration and partnership between dialysis and transplant providers, having worked in multiple capacities as a dialysis facility level social worker, dialysis social work manager and a kidney transplant social worker at Duke University Hospital.
